JOB PURPOSE

Under the direct supervision of the Senior Compliance Officer (FMG/AS 3), the Compliance (FMG/AS 2), examines internal control procedures, cashbooks, and receipt and payment logs against deposit and withdrawal slips in the People's Co-operative Banks island wide in accordance with the Agricultural Credit Board/FAA Acts.

KEY RESPONSIBILITIES

Technical/Professional Responsibilities

- Plans, organizes, direct and controls the schedules/inspections in the People's Cooperative Banks
- Schedules the relevant Assistant Inspectors to audit assignments
- Prepares monthly reports based on audits and inspections carried out
- Checks all cash transactions to ensure that there is a balance in the cash books
- Inspects receipt and payment log to ensure accuracy
- Analyses and examines periodic information collected from P.C. Banks
- Makes recommendations regarding corrective measures and improvements to the system as it related to P.C. Banks
- Writes intervention reports based on audits carried out
